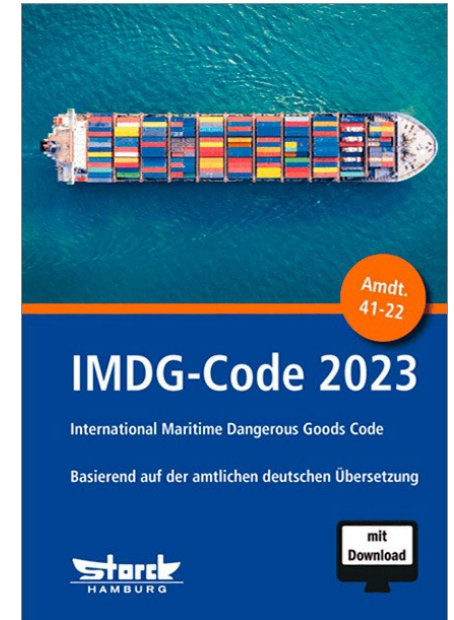
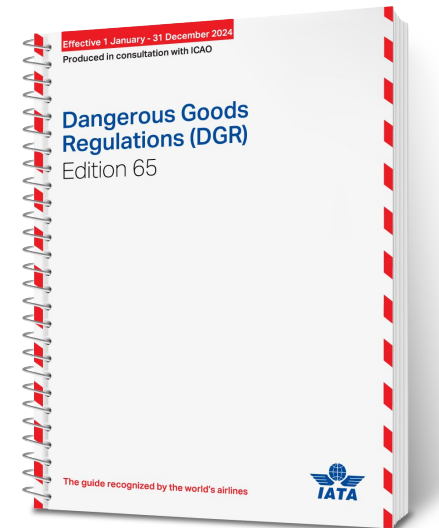
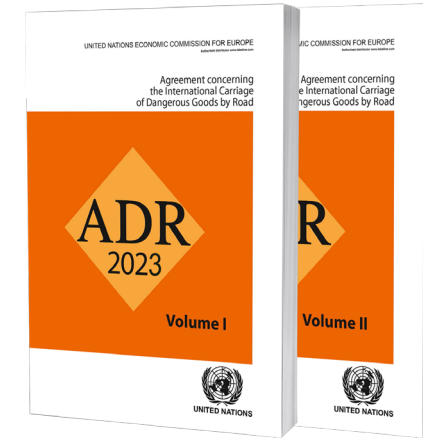


# Information about hazardous and dangerous goods

## Transport regulations

Hazardous goods in terms of the current transport regulations ADR, IMDG-Code and IATA-DGR are shipped by Waldner Laboreinrichtungen together with laboratory furniture or separately.

These products (e.g. glues, colorants) are required to remove minor defects during installation of laboratory furniture.

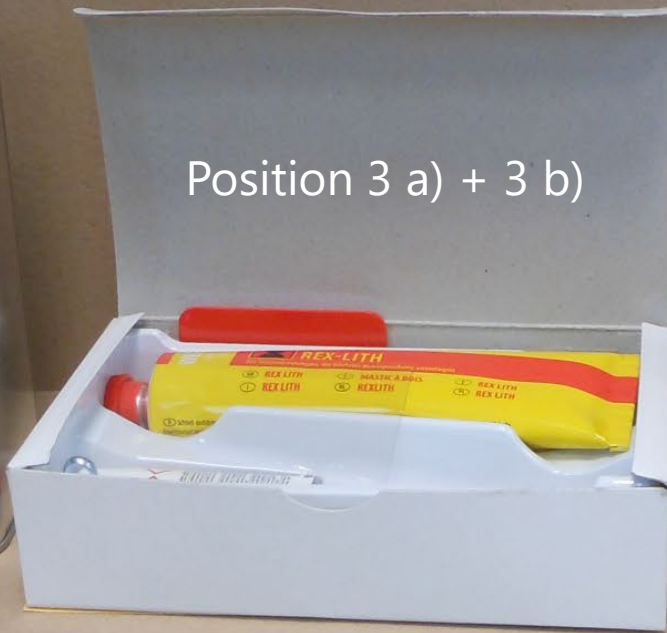

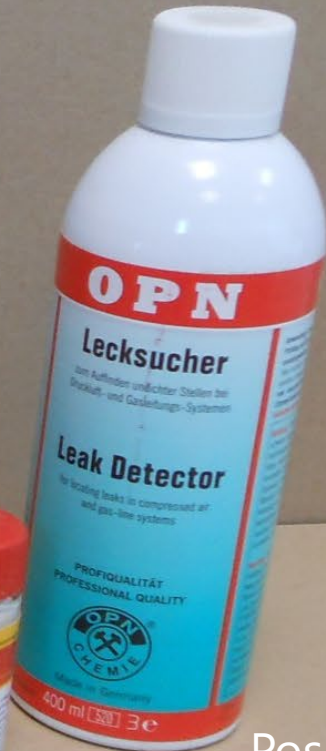

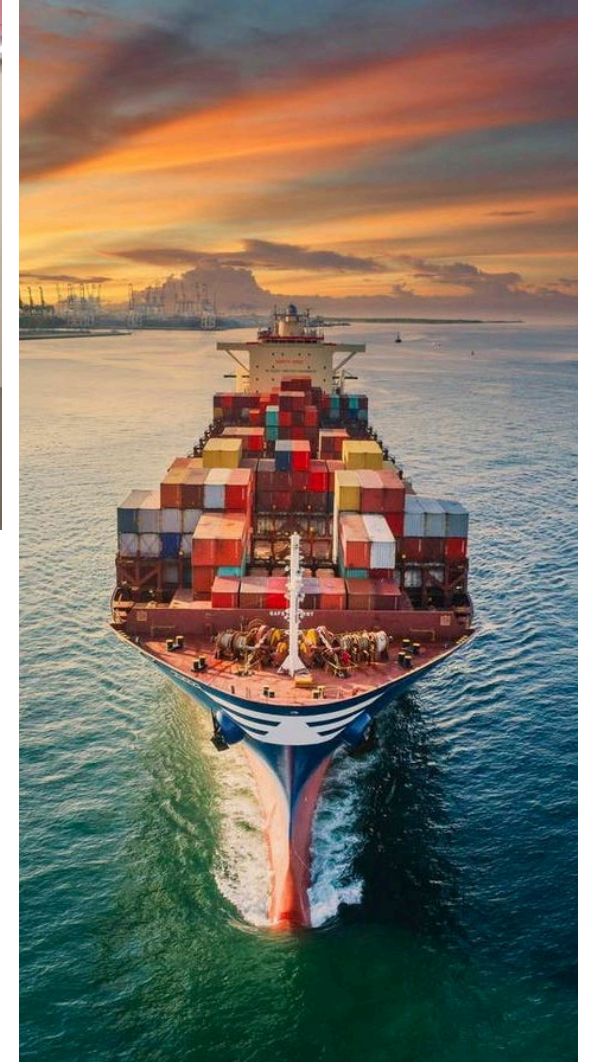

# Information about hazardous and dangerous goods

At Waldner Lab Space Solutions

- These products only contain hazardous parts in very low quantities (max. 1 litre/kg).
- The items are packed and loaded by the Waldner Laboreinrichtungen staff in Germany according to the current transport regulations (road and sea) by applying the exemption as per chapter 3.4 ADR/IMDG-Code (limited quantities - LQ).
- For transport in the air (IATA-DGR) we are using the standard rules.
- Furthermore such products are available for everyone in retail stores, among other things.
- There is no risk for the user under normal conditions and in proper use.
